

Off Season Limited Service Camping

Off season limited service camping reservations for RV sites, campsites or cabins may be made with either the Superintendent of Parks, or the Park Ranger. All reservations must be made at least seven (7) days in advance, and can be done so by calling the Mayo Park offices during business hours. Any facilities requiring keys for access must be picked up at the Mayo Park office or the Person County Recreation, Arts, and Parks Department main office during regular business hours. Failure to receive keys from Mayo Park, or Recreation Department Staff will result in the forfeiture of the renter's facility.

Nightly rental fees and an additional security deposit of \$50 for Small Cabins, \$50 for Large Cabins, \$50 for waterfront tent sites, \$50 for RV Sites, \$50 for primitive camping, or \$50 for group primitive camping will be paid in full at the time of reservation. Credit Card on file may be allowed/substituted for Deposit of all off season rentals.

The renter is financially responsible to any damages or loss of county property that may occur to their rented facility. Deposits for any facility reserved will not be returned if the Superintendent of Parks or representative determines that the facility was damaged or left in a condition not compliant with the off season limited service camping agreement.

Mayo Park staff reserves the right to close the park, cancel any and all reservations, or refuse any reservation if the staff believes dangerous conditions may exist, or has the potential to exist, due to weather, maintenance or construction projects, or any other factor. In the case that your reservation is cancelled, the renter will have the option of moving their reservation to a later time, or a full refund will be issued. Further, access to facilities other than your rented site or cabin, including bathhouses, restrooms, picnic shelters, piers or docks, playgrounds or any other facilities is not guaranteed during off season limited service camping. The superintendent of parks or representative may close any facility if it is deemed necessary for any purpose.

No Mayo Park Ranger, security guard, or other staff member will be on site during your stay. All campers must have an operational cell phone. Please dial 911 in the case of an emergency.

It is the responsibility of all campers to keep the gates locked at all times while the camper or any member of their party is present in the park. It is also the responsibility of all campers to lock the gate behind themselves or any member of their party upon exiting the park for any reason. Campers are financially responsible for any damages or loss of county property that may arise as a result of any failure to comply with this rule. Campers may not receive their deposits if gates are not kept closed and locked.

All renters must vacate their rented facility by the time stated on their contract or permit. Upon departure, any campfires must be extinguished, and all trash or personal property must be removed from any rented facility. Renters of cabins must also lock cabins before leaving them. All keys including gate and cabin keys must be returned to the drop box at

the Mayo Park office before leaving Mayo Park. Failure to return keys may result in our retention of your security deposit.

***Note – If key is determined to be accidentally lost, a \$10 charge will be assessed in place of retention of the deposit.**
